THE PARTIES AGREE THAT IF THE FEDERAL AND/OR STATE PREVAILING RATE FOR THE COVERED WORK HEREIN IS INCREASED BEYOND THE ABOVE WAGE RATE(S) DURING THE TERM OF THIS AGREEMENT, THEN THE EMPLOYEES COVERED HEREUNDER SHALL BE IMMEDIATELY PAID AT THE INCREASED PREVAILING RATE.

** THE COUNCIL RESERVES THE RIGHT TO ALLOCATE THESE INCREASES AT ITS DISCRETION AMONG WAGES, FRINGE BENEFITS AND DUES DEDUCTIONS.

*** ARTICLE III, SECTION 2, \$5.00 WAGE PREMIUM FOR ANY JOB IN ZONE 2 REQUIRING A FEDERAL SECURITY CLEARANCE. FOR EXAMPLE, WORK WITHIN A NUCLEAR POWER PLANT SITE, A NAVY YARD, MILITARY BASE OR OTHER SECURED FEDERAL ENCLAVE.
